**Fresno County Supervisor, Sal Quintero is pleased to announce the joint efforts of his District Office, Fresno County Public Works and Planning, PG&E and the Fresno County Sheriff's Department, in the installation of alley grindings/paving and of alley and street lights in Calwa, to provide access and line of sight that enhances public safety and public/environmental health.**

Fresno, California, May 15, 2019, 10 am, at the alley entrance on Grove Avenue between 9<sup>th</sup> and 10<sup>th</sup> Streets in Calwa: Fresno County Supervisor Sal Quintero will host a Press Conference to announce the continued multi-million dollar investment in the decade's long neglected Calwa area, which includes:

- Asphalt grindings to pave the alleyways (currently being installed)
  - Improves access for Public Safety for, Sheriffs, Fire, Ambulance, as well as Fresno County Public Works and PG&E for maintenance
  - Improves access for the citizens of the community
  - Allows public access as alternative pedestrian routes
- Alley and Street Lighting (installed and donated by PG&E)
  - Improves line of sight for Public Safety for the Sheriff's Department and first responders
  - Acts as a deterrent to criminal activity
  - Provides safer access to the public and community
- Fresno County Lead Based Paint Abatement Program
